National Treasury and the Financial Sector Conduct Authority (FSCA) have launched Money Smart Week South Africa 2022 (MSWSA 2022), which will take place from 29 August until 4 September 2022.

MSWSA 2022 is an initiative of the National Consumer Financial Education Committee (NCFEC).

The NCFEC was established to secure active involvement, collaboration and coordination of various stakeholders in consumer financial education and is chaired by National Treasury.

The objective of the launch is to create awareness around the campaign which aims to motivate, empower, and educate South Africans about their financial well-being.

Delivering a keynote address during the launch on Thursday, Commissioner of the FSCA, Unathi Kamlana, encouraged previous and prospective participants to join the MSWSA 2022 campaign.

SA records 253 new COVID-19 cases in the past 7 days





South Africa now has 4 008 697 COVID-19 cases after 253 new infections were logged in the past seven days, the Department of Health said on Wednesday.

Meanwhile, the death toll is sitting at 102 066 after 56 fatalities were recorded in the past week.

The latest data also show that the country is now home to 5 299 active cases, of which 1 430 can be found in KwaZulu-Natal, 1 329 in the Western Cape and 578 in Gauteng.

In addition, the recovery rate is standing at 97.3%, meaning 3 897 607 people beat the respiratory disease since the outbreak.

Ramaphosa signs new municipal law for South Africa





President Cyril Ramaphosa has signed the Local Government: Municipal Systems Amendment Bill into law, barring municipal workers and senior managers from holding political office in South Africa.

The bill prohibits all municipal officials from holding political office and also empowers MECs to take appropriate steps, which includes the application of declaratory orders on the validity of appointments to enforce compliance.

The new laws replace the 2011 Amendment Act, which had a political office ban that only applied to municipal managers and their direct reports.

South Africa can avoid 'greylisting' says Kganyago





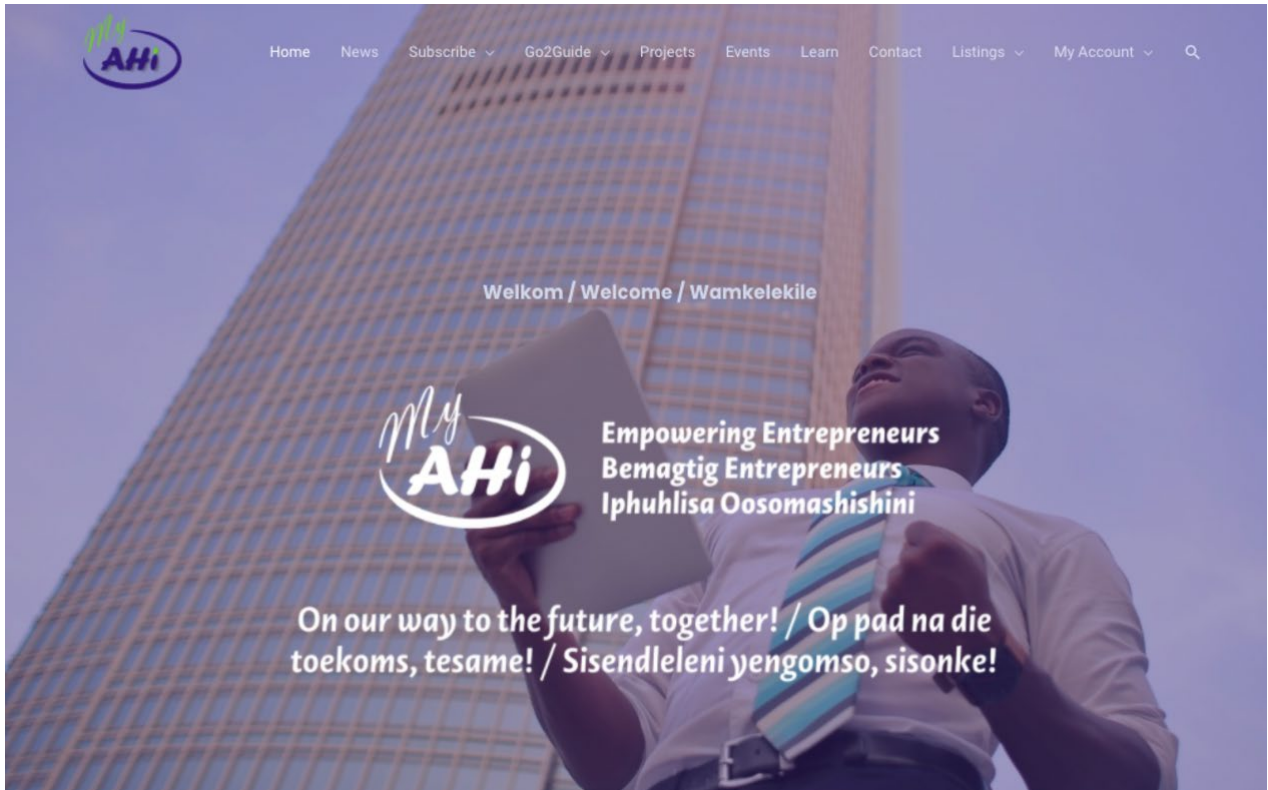
South Africa can avoid possible ‘greylisting’ if it were to implement recommendations contained in the Financial Action Task Force (FATF) mutual evaluation report, says South African Reserve Bank (SARB) governor, Lesetja Kganyago.

The FATF commenced its assessment in 2019 and published its final report on 7 October last year. The mutual evaluation report had an adverse rating under technical compliance and effectiveness. It made several recommendations.
