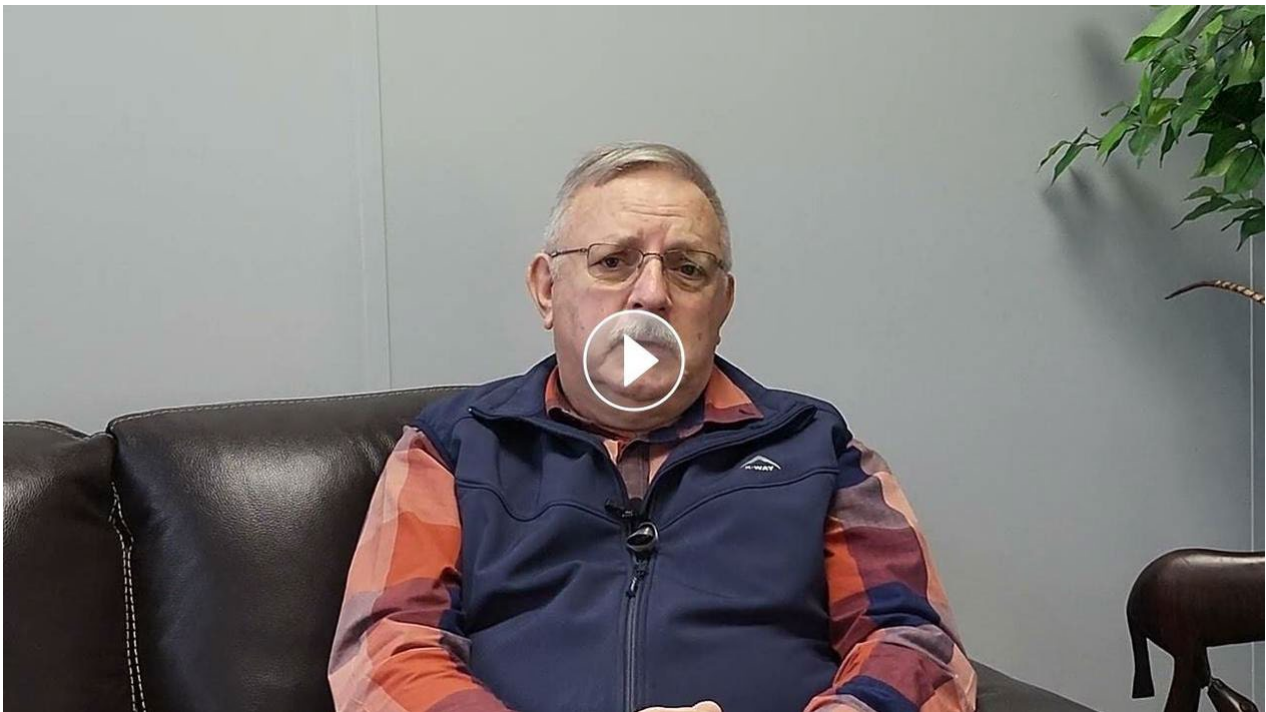

Dr. Willie Cilliers gesels oor die ekonomiese landskap, rompslomp, sakekamers én stygende lewenskostes

Dr. Willie Cilliers, uitvoerende direkteur van die AHi in die Wes-Kaap, het op 1 Julie uit sy kantoor in George met intekenaars gesels.

In die gesprek gesels dr. Cilliers onder andere oor die ekonomiese landskap van Suid-Afrika. Ons verwys ook na die jongste verslag van PwC wat hier op ons webtuiste afgelaai kan word (<https://bit.ly/3yGxx9V>).

Verder gesels Cilliers oor die rol van sakekamers in die moeilike ekonomiese tye, die belangrikheid om rompslomp te verwyder en die impak van stygende lewenskostes in Suid-Afrika.

Rompslomp (*red tape*) verwys na die oordrewe verkleefdheid aan formaliteite en regulasies deur die amptenary. Omrede tyd geld werd is, kan rompslomp onproduktiwiteit meebring, 'n demper op inisiatief plaas, werkstyd inboet en ekonomiese vooruitgang kniehalter.

The South African Revenue Service (SARS) has made significant changes to the 2022 Tax Filing Season. This year, over 3 million individual non-provisional taxpayers have been auto-assessed by SARS and will not have to file a tax return if they are satisfied with the outcome.

The introduction of auto-assessments, among other enhancements this year, is in line with SARS' journey of building a smart, modern revenue service with unquestionable integrity, trusted and admired by all. Technology, the use of data, artificial intelligence and algorithms have enabled SARS to make it easy and seamless for most individual taxpayers to comply with their legal obligations. All these innovations support our strategic objective of providing clarity and certainty to help foster a culture of voluntary compliance.

At the same time, the use of technology and data have also enabled SARS to significantly sharpen its capability to detect non-compliance and to make such non-compliance hard and costly. SARS will impose understatement penalties to taxpayers that deliberately attempt to claim impermissible expenses or understate their income as well as administrative non-compliance penalties to those taxpayers that do not adhere to the applicable deadlines of this Filing Season.

Taxpayers should be aware that SARS has access to various sources of data, which enables us to track economic activity and verify the completeness and accuracy of tax declarations.

South African labour groups agreed to a wage offer from the state-owned power utility, ending an impasse over increases that triggered a week of illegal protests and deepened electricity outages.

Eskom, which generates almost all of the nation's electricity, was scheduled to meet with the unions on Tuesday (5 July) over the pay deal.

Members of South Africa's National Union of Mineworkers and the National Union of Metalworkers of South Africa will accept the utility's offer of a 7% wage increase, NUM General Secretary William Mabapa said in an interview with broadcaster Newzroom Afrika. South Africa's consumer inflation rate was 6.5% in May.

Alternative petrol price proposed for South Africa





The opposition Democratic Alliance has submitted its Fuel Price Deregulation Bill to parliament for processing.

The bill aims to amend the existing Petroleum Products Act, which gives the government the power to prescribe the price of petroleum products. The bill is set to be gazetted for public comment in the coming weeks.

“The primary objective of the Bill is to deregulate the fuel sector to increase competition in fuel price-setting at both the wholesale and retail level, which will result in lower petrol prices for consumers, as retailers compete to win customers based on price levels,” said the party’s Kevin Mileham.

- Wednesday and Thursday loadshedding stages are confirmed.
- The stage of loadshedding for Friday – Sunday is dependent on returning generating units to service and will be confirmed closer to the time.

South Africa has largely adapted to stage 2 load shedding, say economists at the Bureau for Economic Research (BER), but beyond these levels, households, businesses, and the economy at large simply cannot cope.

State power utility Eskom announced load shedding at various stages this week, starting with stage 4 load shedding during the day on Monday, escalating to stage 6 during the evening peak, before falling back to stage 4 overnight.

This rollercoaster schedule will be in effect for most of the week, with the power utility expressing some hope that the situation will stabilise to around stage 2 load shedding by the weekend.

Jobs that pay the highest average salaries in SA





Employment data from Statistics South Africa reveals those workers in the country's formal, non-agricultural sectors who earn the best average salaries.

Stats SA's Quarterly Employment Survey data covers eight key industries or sectors in South Africa, which is split further into 20 sub-categories, mainly made up of various manufacturing sectors, as well as a split between the government and non-government community, and social services.

The whole dataset covers earning estimates across 90 different job types in the formal, non-agricultural sector, indicating which job types or sectors draw the highest monthly earnings.

Department launches program for tech entrepreneurs





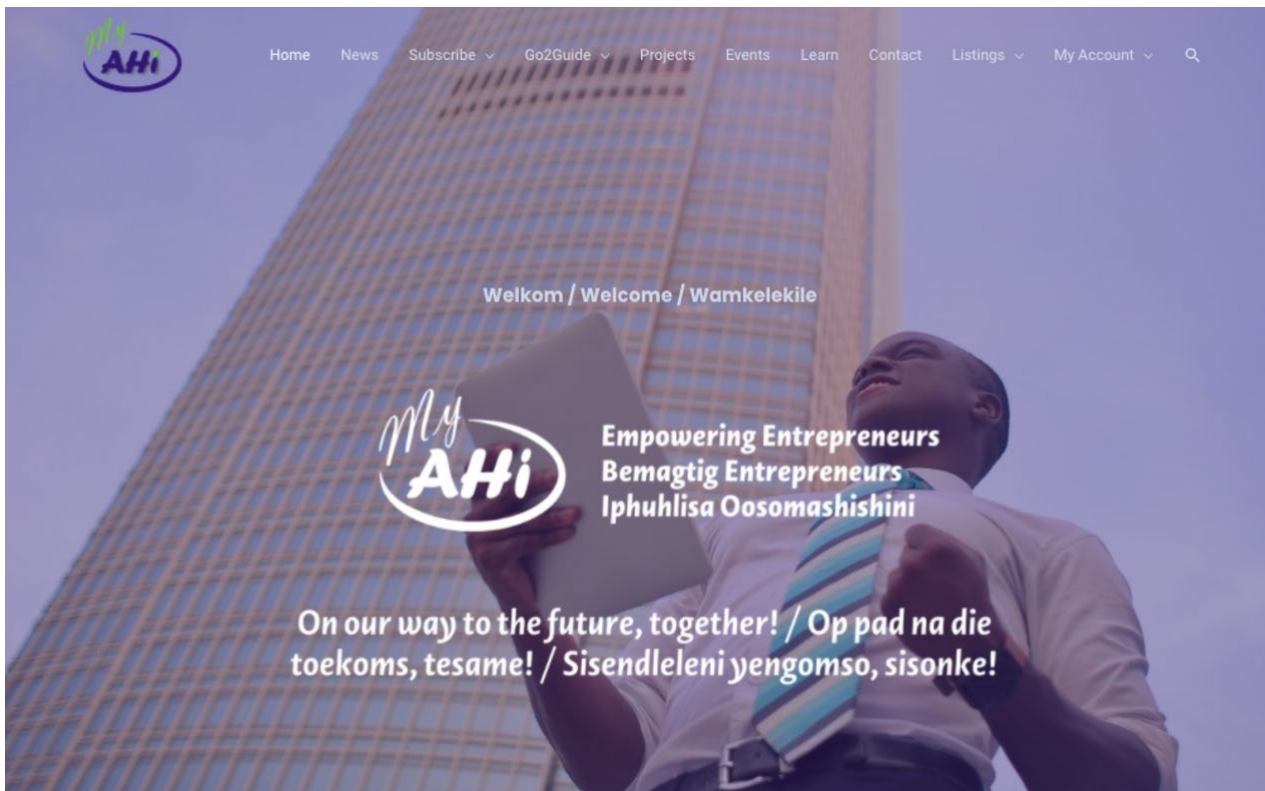
Digitalisation has the potential to open new frontiers and improve resource management efficiency and sector competitiveness in tourism, says the Department of Tourism.
